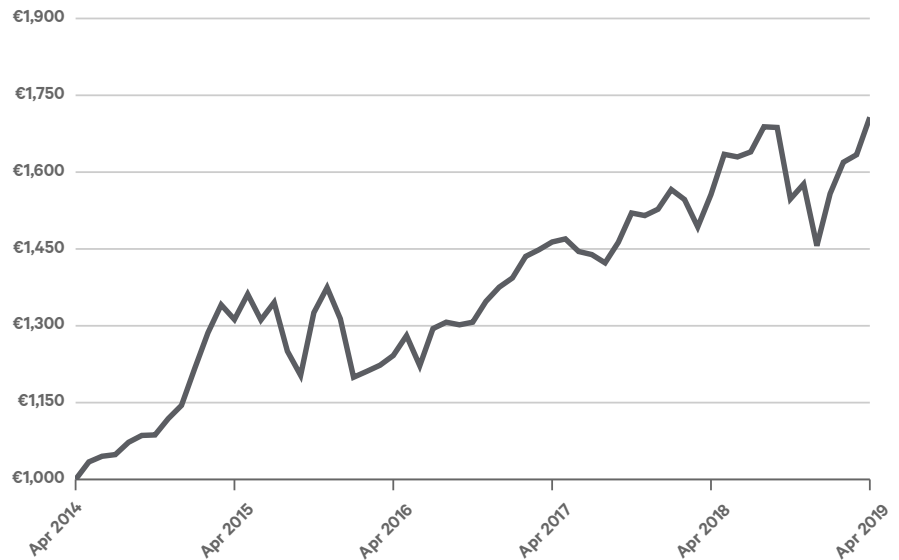

FIGURE 2: Geographic Allocation (% Fund)**

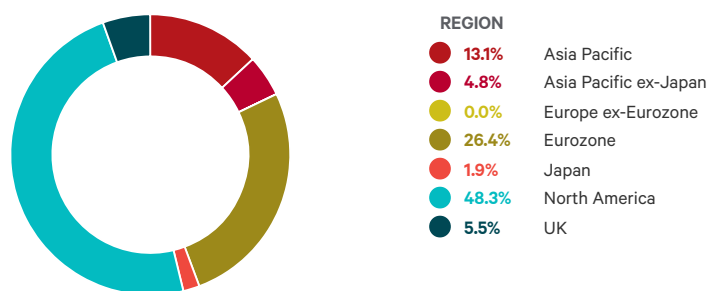
