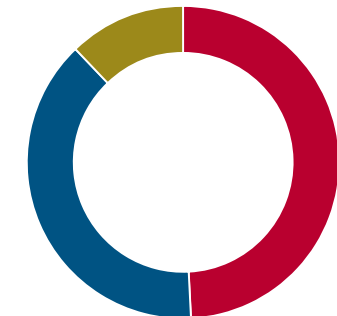

FIGURE 2: Asset Allocation\*\* (% Fund)

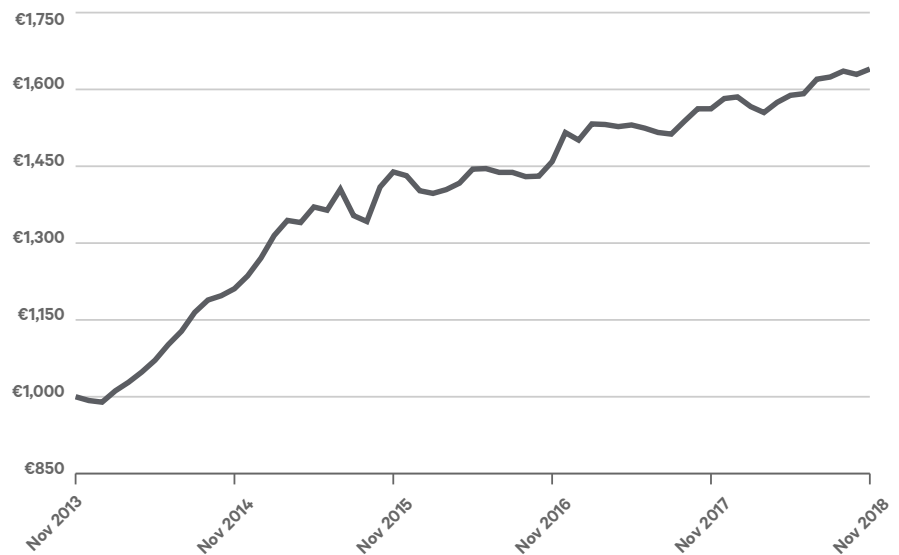

### MONTHLY COMMENT

After continued market weakness at the start of the month, global equities rallied late in November to record a positive 1.2% performance for the month. Healthcare, Real Estate and Utilities stocks were best performers with Oil stocks performing worst. The oil price fell from \$75 at the start of the month to \$59 by month end, the drop was the largest monthly fall in over a decade. European corporate bonds were negative for the month of November with the Bank of America AAA-A Euro Corporate Index falling by -0.45%. The Fund underperformed the benchmark by -0.24% due to security selection. Within Property, income growth remains attractive. Current asset breakdown is approx. 39% High Yield Equities, 49% Property and 12% Corporate Bonds.
